

360ISM STUDIOS INDEPENDENT CONTRACTOR AGREEMENT FOR MODELING SERVICES

This Independent Contractor Agreement for Modeling Services (the "Agreement") is made and entered into on [insert date] (the "Effective Date") by and between [360ism Studios] hereby referred to as (the "Company") and [insert model name] (the "Model"), collectively referred to as the "Parties."

RECITALS:

WHEREAS, the Company is engaged in the business of providing modeling services to photographers; and

WHEREAS, the Model desires to provide modeling services to the Company as an independent contractor; and

WHEREAS, the Parties desire to set forth their respective rights and obligations with respect to such services.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

SERVICES. The Model agrees to provide modeling services to the Company as an independent contractor. The modeling services shall include wearing various styles and shooting for a group of photographers at the Company's studio.

COMPENSATION. The Model shall be paid by the Company in accordance with the number of photographers who RSVP to shoot them. The Company shall pay the Model within [insert time period] of the completion of the modeling services. The Model acknowledges and agrees that the compensation paid to the Model is the sole consideration for the Model's services.

PROMOTION. The Company shall promote the Model across social networks and newsgroups as to their arrival and styles of modeling. The Model who is promoted in advance of the event shall be liable for promotional charges totaling up to \$300.00 if they fail to show up on the agreed upon date and time of the event. The Model client will without fail remit the total fee for promotion \$300.00 in the event that they do not show up for the event. Failure to forward the promotional charge will result in a lawsuit being filed for unpaid marketing and promotion of the model.

CANCELLATION. The Company may decide to cancel the event/contract if there are not enough photographers booking the model talent or if engagement is low based on the style and popularity of the model.

REJECTION OF CLAIMS. The Company reserves the right to reject any claims or excuses for no-shows or last-minute cancellations from the Model.

TERM. This Agreement shall commence on the Effective Date and continue until the completion of the modeling services, unless earlier terminated in accordance with the terms of this Agreement.

INDEPENDENT CONTRACTOR STATUS. The Model acknowledges and agrees that they are an independent contractor and not an employee, partner, or agent of the Company. The Model is solely responsible for all taxes, insurance, and other obligations arising out of the Model's services under this Agreement.

CONFIDENTIALITY. The Model agrees to maintain the confidentiality of all trade secrets, confidential information, and other proprietary information of the Company.

TERMINATION. Either Party may terminate this Agreement at any time upon written notice to the other Party. Upon termination, the Model shall immediately return to the Company all Company property, including but not limited to, all materials and equipment provided by the Company.

GOVERNING LAW AND JURISDICTION. This Agreement shall be governed by and construed in accordance with the laws of [insert state or country], without giving effect to its conflict of laws principles. The Parties agree that any disputes arising out of or in connection with this Agreement shall be resolved in the state or federal courts located in [insert city and state], and each Party hereby consents to the jurisdiction of such courts.
