

## 360ism Model & Image Release Form

Talent (models, entertainers) shooting with 360ism agree to the following terms.

The terms of this shoot in which you are a participant are as follows:

- Time for Print/Trade for Publication All of the images which are determined to be 'good for publishing' (images which display the talent/model(s) in their best portrayal) will be submitted to magazine/publication/periodicals. Publications accepting these images will result in the Talent/Model(s) being given official tearsheets with the publishing date.
- Talent/Model(s) contact info such as website, social media page(s) and/or interview will be sent with images for
  publication. \*3rd party editors wishing to utilize the images may or may not include the info when publishing
  images.
- Talent/Model(s) have full right (without needing additional permission) to post the final edits of submitted images to their own website, public websites, social media accounts.
- Talent has the right to print the images on for personal use.
- Talent agrees to credit the photographer for images posted online (social media/private or public pages)
- Talent/Model(s) will not alter (re-edit or digitally manipulate) images taken by the photographer for publishing unless granted permission by the photographer (360ism).
- Talent/Model(s) agrees that the images taken during this TFP session are available for magazine (physical/digital) submission portfolio and /or online promotion; Images which are published in magazines/periodicals/publications are not subject to any additional terms/ payments and/or compensation.
- Unless agreed upon Talent/Model agrees not to post or utilize images on paying sites (adult sites and patreon sites, etc. Only Fans, etc.
- Talent agrees that images will not be utilized in whole or part (altered) for NFT sale.
- Talent/Model will be given up to 6 images of their choice per look/style
- The Talent/Model(s) hereby grants the Photographer the exclusive, perpetual, and worldwide right to use, reproduce, display, distribute, and promote the resulting images in any and all media, including but not limited to the Photographer's website, social media, and any other promotional materials, without any further compensation to the Model.
- The Talent/Model(s)acknowledges that the images may be used for commercial purposes and that the Talent/Model(s)will not receive any compensation for such use, other than as stated in this Agreement.
- The Photographer shall have the right to sell the images and shall be entitled to retain all proceeds from the sale of the images.
- The Talent/Model(s) represents and warrants that they have the right to enter into this Agreement and that they have not entered into any other agreement or commitment that would conflict with this Agreement.
- The Talent/Model(s)releases the photographer from any liability for any claims by any third party in connection with the use of the images.

This contractual agreement applies to TFP, Compensated photoshoots and well as publications owned by 360ISM Publishing or for images that will be submitted to Third party publications.

I grant to 360ISM Publishing, its representatives and employees the right to take photographs of me and my property in connection with the above-identified subject. I authorize 360ISM Publishing, its photographers and transferees to copyright, use and publish the same in print and/or electronically. I agree that 360ISM Publishing may use such photographs of me for any lawful purpose, including for example such purposes as promotion publicity, illustration, advertising, and Print/Web content. I hereby waive to the fullest extent that I may lawfully do so, any causes of action in law or equity I may have or may hereafter acquire against 360ISM Publishing for libel, slander, invasion of privacy, copyright or trademark violation, right of publicity, or false light arising out of or in connection with the utilization of any images, moving picture and interview dialogue.
